# 4. 個人資料的保留

本公司及其香港股份過戶登記分處將按收集個人 資料所需的用途保留證券申請人及持有人的個人 資料。無需保留的個人資料將會根據條例銷毀或 處理。

# 5. 查閱和更正個人資料
