**SUMMARY**

**Offer Price and Net Proceeds from the Share Offer**

- The Offer Price has been determined at HK\$1.22 per Offer Share (excluding brokerage of 1%, SFC transaction levy of 0.0027% and Stock Exchange trading fee of 0.005%).
- Based on the Offer Price of HK\$1.22 per Offer Share and 70,000,000 Offer Shares, the net proceeds from the Share Offer, before the exercise of the Offer Size Adjustment Option and after deducting the underwriting commission and fees and other estimated expenses payable by the Company in relation to the Share Offer, are estimated to be approximately HK\$61.2 million. The Company intends to apply such net proceeds in accordance with the purposes set out in the section headed “Future Plans and Use of Proceeds” in the Prospectus.

## Applications under the Public Offer

- The Offer Shares initially offered under the Public Offer was very significantly over-subscribed. A total of 7,183 valid applications were received pursuant to the Public Offer on **WHITE** and **YELLOW** Application Forms and through giving **electronic application instructions** to HKSCC via CCASS and through the **HK eIPO White Form** Service Provider under the **HK eIPO White Form** service for a total of 178,558,000 Public Offer Shares, representing approximately 25.5 times of the total number of 7,000,000 Public Offer Shares initially available for subscription under the Public Offer.
- Accordingly, the reallocation procedures as disclosed in the section headed “Structure and Conditions of the Share Offer” in the Prospectus have been applied. As the number of Offer Shares validly applied for in the Public Offer represents more than 15 times of the number of Offer Shares available under the Public Offer, 14,000,000 Offer Shares have been reallocated from the Placing to the Public Offer, such that the final number of Offer Shares allocated to the Public Offer has been increased to 21,000,000 Offer Shares, representing 30% of the total number of Offer Shares available under the Share Offer.

## The Placing

- The Offer Shares initially offered under the Placing have been slightly over-subscribed. A total of 76,240,000 Placing Shares have been subscribed, which is equivalent to approximately 1.21 times of the total number of 63,000,000 Placing Shares initially available under the Placing. As a result of the reallocation, the final number of the Placing Shares allocated to 216 places under the Placing is 49,000,000 Placing Shares, representing 70% of the total number of the Offer Shares under the Share Offer (before the exercise of the Offer Size Adjustment Option). A total of six places have been allotted Placing Shares of 10 board lots or less, representing approximately 2.8% of the total number of the 216 places under the Placing.
- Out of the 49,000,000 Placing Shares, (i) 250,000 Placing Shares (representing approximately 0.510% of the total number of Placing Shares and approximately 0.089% of the enlarged issued share capital of the Company immediately after completion of the Capitalisation Issue and the Share Offer), have been allocated to Mr. Lau Ning Wa Ricky (“**Mr. Lau**”), who is a director and shareholder of Joy Rich Securities Investment Limited (“**Joy Rich**”), a sub-underwriter under the Placing; and (ii) 250,000 Placing Shares (representing approximately 0.510% of the total number of Placing Shares and approximately 0.089% of the enlarged issued share capital of the Company immediately after completion of the Capitalisation Issue and the Share Offer), have been allocated to Mr. Kong Ka Leung (“**Mr. Kong**”), who is an employee of Joy Rich. Therefore, pursuant to Note 2 to Rule 10.12(4) of the GEM Listing Rules, Mr. Lau and Mr. Kong are connected clients of Joy Rich.

### **Offer Size Adjustment Option**

- In connection with the Share Offer and pursuant to the Placing Underwriting Agreement, the Company has granted to the Joint Bookrunners (for themselves and on behalf of the Underwriters) the Offer Size Adjustment Option to cover over-allocations under the Placing (if any). Pursuant to the Offer Size Adjustment Option, the Company may be required to allot and issue, at the Offer Price, up to an aggregate of 10,500,000 additional new Shares, representing 15% of the number of the Offer Shares initially available under the Share Offer (assuming that the Offer Size Adjustment Option is not exercised). The Offer Size Adjustment Option has not been exercised by the Joint Bookrunners and has accordingly lapsed.

Based on the Offer Price of HK\$1.22 per Offer Share and 70,000,000 Offer Shares, the net proceeds from the Share Offer to be received by the Company, after deducting the underwriting commission and fees and other estimated expenses payable by the Company in relation to the Share Offer and assuming the Offer Size Adjustment Option is not exercised, are estimated to be approximately HK\$61.20 million. The Company currently intends to apply such net proceeds as follows:

- approximately HK\$20.89 million or approximately 34.13% of the net proceeds will be used to strengthen our ability in obtaining exclusive contracts and/or sale agency contracts on new products and fulfilling the minimum purchase amounts under such contracts so as to broaden our frozen seafood product offerings;
